Data Sharing

After 9/11 the word “interoperability” became the buzz word for bigger and more complex sharing of law enforcement data – from local to state to national to international venues.

The **Black Hawk County CJIS** agencies in Iowa were pioneers in local data sharing back in the late 1970’s when they implemented their Records Management System to include the Black Hawk County Sheriff’s Office, Cedar Falls Police Department, Evansdale Police Department and the Waterloo Police Department. They continue to share data on the local level.

The following are some of the other data sharing venues our clients are involved with:

OLLEISN (Ohio Local Law Enforcement Information Sharing Network) is a secure, Internet-based system designed to

enable Ohio local law enforcement agencies to share law enforcement information with each other. Local agencies submit information to OLLEISN through a secure Internet pathway to the Ohio Attorney General’s Ohio Law Enforcement Gateway (OHLEG) Office. OLLEISN retrieves and shares multi-jurisdictional information about persons, locations and property related to: wants and warrants, incident data, alerts and other locally collected information.



N-Dex (National Data Exchange) is a national information sharing system that helps solve crimes and connect the dots between people, places, and events.

The FBI’s Criminal Justice Information Services Division in West Virginia was asked by the Department of Justice to develop and maintain N-DEX. Information

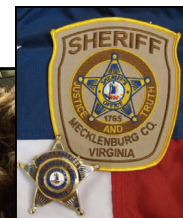

from the FBI's website defines the vision of N-DEX: to enable the sharing of complete, accurate, timely, and useful information across jurisdictional boundaries and to provide new investigative tools that enhance the nation's ability to fight crime and terrorism.

LInX - NCIS launched the Law Enforcement Information Exchange (LInX) initiative in 2003. The project was designed to enhance information sharing between local, state, and federal law enforcement in areas of strategic importance to the Department of the Navy. LInX provides participating law enforcement partner agencies with secure access to regional crime and incident data and the tools needed to process it, enabling investigators to search across jurisdictional

boundaries to help solve crimes and resolve suspicious events. LInX sites are currently operated by NCIS and its partners in nine regions throughout the U.S.



The nine regions are:

- **Northwest**, encompasses 217 agencies within the State of Washington, as well as parts of Oregon and agencies within the State of Alaska;
- **Hampton Roads**, encompasses 106 agencies in the Norfolk and Richmond areas of Virginia;
- **Southeast**, with 69 agencies in the northern area of the State of Florida, as well as agencies in the southeastern

area of the State of Georgia;

- **Gulf Coast**, with 32 agencies in the southeastern coastal area of Texas;
- **Hawaii**, with 6 agencies;
- **Rio Grande**, with 39 agencies in the central area of New Mexico;
- **National Capital Region**, with 126 agencies in southern Maryland, northern Virginia and the District of Columbia;
- **North Carolina**, with 47 agencies' data in the eastern portion of the state; and
- **Southern California**, comprised of 34 agencies.

A Northeast region is presently in development and includes 20 agencies in the southeastern section of Connecticut.

Data Integration with the City of Roanoke – Shield clients in the Roanoke, VA area will be participating in this local data sharing project.
